The information on the FUND “SEVASTOPOL”

The NGO Public Non-Profit Organization “Fund “Sevastopol” was established in January 2009 upon the initiative of the Sevastopol residents being experienced in the economic relations. The Fund, due to its close relations with Sevastopol Authorities and business community, functions as Regional Development and Investment Promotion Agency. The Fund is appointed by the Sevastopol City State Administration to coordinate the implementation of the Sevastopol Investment Promotion Strategic Plan by the Decision of the City Council № 8523 of 15.12.2009.

The objective of the Fund is to assist government, public and private organizations and companies of Sevastopol in implementation of different programmes, projects and initiatives of social and economic development of Sevastopol, to promote domestic and foreign investment as well as to raise the employment rate in the city. During its time of existence the Fund established contacts with the leading domestic and foreign governmental and non-governmental organizations and institutions, large bank and law companies, embassies, mass media etc.

Inter alia the Fund “Sevastopol” established contacts with Embassies like the World Bank, KfW, EBRD, US, German and UK Embassies to the Ukraine, USAID, EU-Ukraine Business Council (Brussels), US-Ukraine Business Council (Washington), and prominent international companies like “Skadden, Arps, Slate, Meagher & Flom” and “Maitland” law firms (London), Parsons, GEA (both USA), Remondis (Germany) engineering companies and many others. At the national level the Fund coordinates its activities with the structures of the Cabinet of Ministers of Ukraine, Ministries of Economy and Foreign Affairs of Ukraine, the Autonomous Republic of Crimea Authorities, the Sevastopol City State Administration and the City Council, local business structures.

The Fund has arranged more than 30 different significant events, such as the presentation of Sevastopol in the British Parliament and arranging of the Sevastopol delegation visit to the United Arab Emirates. The Fund participated in the organization of the Day of Europe celebration in Sevastopol (May 2010) with delegations of 11 Embassies and 6 Ambassadors of the EU countries, the meeting of the international Trade Club (April 2009), different seminars, international trainings and business meetings. The Fund also initiated visits to Sevastopol by the US Embassy Trade and Investment Mission, European Commission delegation and many more. All of these visits were aimed at promotion of Sevastopol’s new strategy of peaceful development at the world-wide level and attraction of investments to Sevastopol.
